### Citizen Communications

- Mark Roberts – spoke about 1404 E 2<sup>nd</sup> demolition permit (or a relocation of the structure outside of the city limits)

### Approval of Minutes

- **Motion:** Moved by Kristen Hotopp and seconded by Sara Pedrosa that we postpone the approval of the May and June minutes until the August General Meeting. The motion unanimously carried.

### Officers’ Reports

- Revising the roles of ECCNPCT officers was discussed. Concerns were voiced in opposition to the Vice Chari automatically becoming the Chairman after a two-year term. Concerns were also voiced in opposition to the Land Use Committee Chairman automatically being a ECCNPT Vice Chairman.

## Main Motions

- **Motion:** Moved by Sara Pedrosa and seconded by Kristen Hotopp that the revised ECCNPCT board responsibilities be approved with the exception that Vice Chair does not automatically become the Chairman at the end of a two-year term and that the Land Use Committee Chairman does not also automatically serve as Vice Chairman. The motion unanimously carried.
- **Motion:** Moved by Sylvia Marroquin and seconded by Sara Pedrosa that the vote on Kristen Heaney for the Sector 8 Representative and the Chairman role election be postponed. The motion unanimously carried.
- **Motion:** Moved by Kristen Hotopp and seconded by Sylvia Marroquin that the ECCNPCT send a letter (written by Kristen) to Steve Sedowsky of The Historic Landmark Commission letter in opposition of the demolition permit for 1401 East Third Street. The motion carried with 6 in favor and 1 abstention.
