## **Application Checklist**

To be considered for a position on our leadership team, please submit the following documents

- ❖ Application Form- *Fill out application form or submit the equivalent information to the committee chairperson.*
- Community Signatures- Please collect the signatures of ECC community members who will endorse your nomination. There is no minimum or maximum number of signatures required. Alternately, letters of endorsement can be sent to the committee chairperson.
- Statement of Interest- this is the applicant's opportunity to discuss his/her connection to the neighborhood, why (s)he is interested in joining the leadership team, and what skills or talents (s)he will contribute to the organization.
  Statement letters need not be longer than one page. Examples of past statements are included here for your reference.
- Please contact the committee chairperson if you have further questions.

## Bylaws & Neighborhood Plan

Before submitting an application to join the ECC NCT leadership team, all applicants should review the team bylaws and the neighborhood plan. Both documents are available to view on our website, or contact the Nomination Committee chair to obtain a printed copy.

## Guidelines and Responsibilities of ECC-NPCT Representatives

#### From the ECC NPCT Bylaws

#### 2.1 Membership

Members of the ECC-NPT shall be residents of Austin who live in, work in, or own property within the established East Cesar Chavez Neighborhood (ECC) boundaries. Members of the ECC-NPT may be elected to the Leadership Team representing their Sector and vote on issues consistent with the views of their Sector along with their own knowledge and understanding of the issues and the adopted Neighborhood Plan. Members interested in becoming a member of the Leadership Team shall provide their current street address and/or business address or property address, email address and home telephone number and provide a description of their interests and qualifications to the Chairperson at the time of application and whenever addresses or telephone numbers change.

#### 2.2 Selection of Leadership Team Members.

The ECC-NPT Chairperson shall appoint a nominations committee as needed. The committee shall: ensure that notification of open seats are made to our constituents; ensure transparency of the election process; inform the Leadership Team Members of potential new members; confirm the eligibility of potential new members; request a vote at any regular or special called meeting.

#### 2.3 Number, Tenure and Qualifications.

The ECC NPT Leadership Team will consist of 15 members, or 16 members if the Immediate Past Chair position is filled. The nominations committee will consider the following criteria for new Leadership Team members:

#### 2.3.1 Representation.

Leadership Team members fill the following categories either as a Sector Representative or a key stakeholder group as listed below:

- Eight residents elected from the neighborhood's geographic sectors (see map attached)
- One representative of rental residents to express the interests of all renters including low income renters of Chalmers Court and the RBJ Senior Residential Center.
- Three representatives, in total, from congregational, non-profit or registered civic

- groups operating within the ECC NP area with at least two of the Representatives representing nonprofit or civic groups.
- Three representatives from businesses or registered business associations conducting business within the ECC NP area.
- One immediate past chair as described in 3.6.

#### 2.4 Change of Status.

If a Leadership Team Member has a change in status making them no longer eligible to be a member of the Leadership Team as described in 2.3.1 that will create a vacancy in the Team, they shall immediately notify the Chair.

#### 2.5 Community Involvement:

Potential Leadership Team members are encouraged to be involved in organizations that conduct regularly scheduled meetings with resident or businesses within the planning area.

#### 2.6 Commitment:

Potential Leadership Team members should be willing to share their expertise, talent and skills on the ECC NPT and attend any and all regular or special meetings.

#### 2.7 Service:

Potential Leadership Team members should be willing to distribute information to their assigned sector or among the constituency they represent on the ECC NPT. They should be willing to hold open meetings for their constituents. A preference will be given to residents are a) involved in community organizations, neighborhood activities, b) informed about neighborhood issues and c) display leadership potential. The nomination committee will notify the Chairperson or Secretary to place an item on the next regularly scheduled meeting of the ECC NPT to report their nominations. The ECC NPT must approve all new Leadership Team members with a majority vote of those present.

## 2.8 Terms and Duties of Membership.

Leadership Team members shall serve two-year (24-month) terms and shall carry out their duties in accordance with these guidelines. Leadership Team members will pursue the fulfillment of the purpose and objectives of the ECC Neighborhood Plan. At the conclusion of the two year term, Leadership Team members must be re-elected by the majority of the quorum present. If a Leadership Team member does not intend to continue, advance notice is requested. Following any two-year membership, an individual may request to be elected to the Leadership Team for the position, challenging the current sector representative.
