K. Heaney notes that or bylaws state that "membership of the ECC NPCT shall to the greatest extent practicable include at least one representative from each of the following groups within the neighborhood planning area

1) Property owners..."

ECC Team Members convey that in the past representatives have been asked to step down if they move out of the neighborhood even if they still own property. This has been an unwritten code.

K. Heaney notes that there is no specification that a sector rep be a neighborhood resident. Could be a property owner, business owner, renter, or any of the groups identified as appropriate representative groups within the neighborhood planning area. Moving out of the neighborhood will still owning property is not stated as grounds for removal from the ECC.

MOTION – M. Rogers moved and it was seconded to allow Heaney to remain the Sector 8 Residential Rep through the end of her term. Motion was withdrawn.

K. Hotopp says its vague to say we wait to resolve it. We have to be committed to do the work to change the bylaws.

Neighbor says there is no basis for a MOTION. The bylaws don't tell us that we have to remove her.

We need to have a bylaws conversation for the changes to define the sector rep conversations. We need a sub-committee to agree to review and revise the bylaws. We need to state how many terms you can serve. Address any concerns about absentee ownership and ECC representation.

V. Standing Committee/Sector Rep Reports

Land Use:

Fiesta Garden, J. Perez – The garden has been there for 10 years and the RBJ project up to last week we found out that the property line is in the wrong place and they have torn down some of the fence to build a rain garden and pond. We only had a few days to get the word out. Some gardeners are coming back to gardens that are destroyed. The City sent out plans for the property line. Was not a survey. City sent an old survey. J. Perez uncomfortable, doesn't understand how they could have missed this after years of planning. Called our City Councilmen (P. Renteria) for a meeting and he would not. Felt like we had no say and we were taken by surprise.

PARD is saying that the developers are correct.

I have questions. During the process they stake out the property line and it changes.

Eric recommends finding a pro-bono attorney to address this.

<u>STR Committee, K Hotopp – Short Term Rental</u>

Bills have been presented to mandate all STR taxes and rules at state level. Those bills did not make it out of committees
