# **Debrief re: Council approval of NPA Rezoning Request at TX Coffee Traders site, 1400** E. 4<sup>th</sup> St.

request by RC and Beth Beall (represented by Richard Suttle of Armbrust & Brown) for a mixed-use office building height increase from the 40 ft. base height in the Saltillo Regulating Plan to 85 feet.

The project was approved on 2<sup>nd</sup> and 3<sup>rd</sup> reading. CM Tovo attempted to give the item more time and proposed passing on 2<sup>nd</sup> reading only and was supported by Alter, Poole, and Kitchen.. CM Renteria disagreed and the amendment was voted down. Ultimately, CM Tovo was the only CM to vote against the project.
