- Motion: Moved by Shawn Somerville and seconded by Richard Roberts that the ECCNPT send a letter of nonsupport to the Planning Commission on the development of 910 East Cesar Chavez. The motion failed with 3 in favor and 5 against.
- Motion: Moved by Jose Valera and seconded by Leslie Thompson that the ECCNPT draft a letter of support for Revival Cycle's block closure request. The motion unanimously carried.
