# **Local Historic District:**

- Amy reported that UT is working on a wiki site for the East Side. A tutorial will be provided before the next meeting, at 5pm at Terrazas Library.
- Amy is planning the next east side homes tour for April. She is looking for homes and docents; hoping to get children involved.
- She would also like to get a preservation project started, similar to Habitat for Humanity, where neighbors volunteer one weekend a year to help fix up someone's historic home. Holly neighborhood has a similar program.

## Land Use & Design Committee:

- Jeff reported that Jim Arnold filed a neighborhood plan amendment for CURE zoning for the Arnold Oil Building. A CoA facilitator will walk ECCNPT through the process. The hearing is on 1/24 in front of the planning/zoning commission. Add an action item to support this on February agenda.
- Susan met with Don Pitts to discuss CoA plans for SXSW 2012 and how the ECCN is affected. She relayed some of the problems that our neighborhood experienced last year. Don recommended that ECCNPT should send an email to him, the mayor, city council and all interested parties to start the discussion on what they plan to do this year about trash, parking, safety, etc. He relayed that every music venue will have to have a meeting with P.A.S.T.E. before SXSW to learn the rules.
- In November, to coincide with the first Formula 1 race, the CoA will have a music festival in downtown bars. Someone suggested that we invite a P.A.S.T.E. representative to speak to our next meeting.
- Corazon mixed use building is planned for 1000 block of East 6<sup>th</sup> by Cypress Properties. The site
  development permit calls for a 264 unit apartment complex. Susan got a call from Richard Koors
  and Dennis McDaniel for information and she will meet with them, the developers and traffic
  engineer to discuss impact on the neighborhood. They are planning to fix up the adjacent pocket

park instead of the "fee in lieu of" option for drainage. Adjacent TOPS warehouse is being turned into a music venue similar to "Beauty Bar".

# **Affordable Housing Committee:**

- Sabino reported that the Guadalupe Neighborhood Development Corporation is looking for a tax credit for a 20 unit housing on Tillery with a child development center. He would like to write a letter of support from ECCNPT. Vote is unanimous.

### **Traffic and Transportation Committee:**

- Lee Austin and Joel Almazon from the CoA met with Susan to discuss the stoplight requirements at 6<sup>th</sup> and Waller. They have done a traffic study and are comparing the results to the federal minimum requirements for a light. They discussed other 4-way stops and options. Anyone can call 311 to report another dangerous intersection.
- 5<sup>th</sup> street construction from I-35 to Plaza Saltillo will be managed by Rick Colgrom, a project manager for CoA public works. He will come to an ECCNPT meeting to discuss plans, some of which include an overhaul of water, wastewater, parking, paving, curbs. Planned start date is July 2012, with Cap Metro moving old rail tracks in May.

- He is meeting with Royal Grocery next week.
