Affordable Housing Committee:

- Sabino reported that there is \$500,000 in home repair funds available for Holly residents from the Holly Power Plant fund. If it is not used, it may be expanded to ECCN. We should find out in 2 months.

4. Discuss the development of a process and or resources for engaging demolition contractors/ developers regarding the salvage of lumber and architectural details.
 - a. Discussed finding a group to help salvage building materials. Liability and scheduling are concerns. Amy to reach out to Elizabeth Walsh Group and Rhizome Collective.

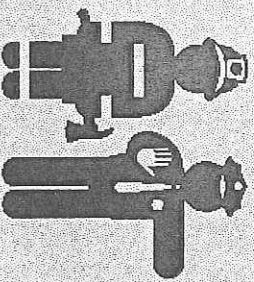

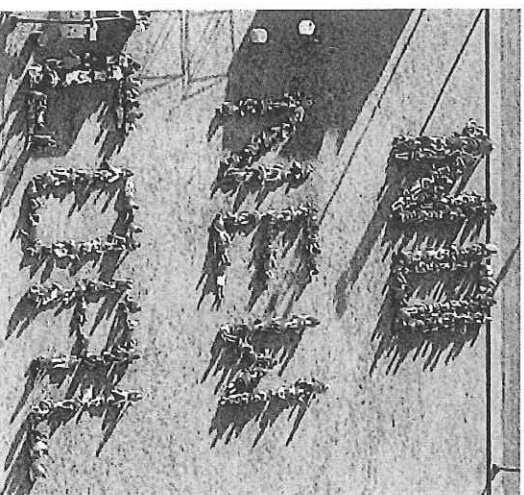

What are the program requirements?

To be eligible for assistance, a family must have owned their home in East Austin for at least 20 years and must earn less than 50% of our area's median family income. In addition, families must agree to participate in a financial planning course.

How much assistance is provided?

Assistance is provided to eligible families on a dollar-for-dollar matching basis, up to \$3000.

What is the project goal?

The goal for this year is to help 12 to 15 families who are at risk of losing their homes due to tax delinquencies.

**Housing Trends for the East
Cesar Chavez & Holly
Neighborhoods**

A study of the Holly & East Cesar Chavez Neighborhoods by the East Austin Conservancy found that out of 488 residential properties studied:

- 96 homeowners have tax delinquencies
- The average amount owed by these 96 homeowners is \$3225.
- Of the 96 homeowners with tax delinquencies, 26 owe more than \$4000
